The country crossed the grim milestone of two crore on May 4, three crore on June 23 and four crore on January 25 this year. Of the 20 more fatalities reported, 11 are from Kerala, three from Maharashtra, two from West Bengal and one each from Bihar, Delhi, Punjab and Rajasthan. A total of 5,24,974 deaths have been reported so far in the country, including 1,47,896 from Maharashtra, 69,935 from Kerala, and 40,114 from Karnataka, 38,026 from Tamil Nadu, 26, 243 from Delhi, 23,532 from Uttar Pradesh and 21,214 from West Bengal.

उत्तर प्रदेश के मैनपुरी जिले में 1600-2000 ईसा पूर्व के तांबे के हथियार और मिट्टी के बर्तनों के दुकड़े पाए गए हैं।
